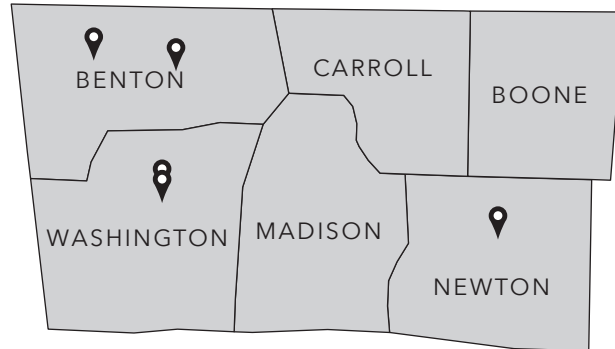


CORRECTIONS VOLUNTEER OPPORTUNITIES
